



# Washington DC October 19-20, 2026

**DAY ONE** - Departure from your area this morning en route to Washington DC. We will have a restroom break and a lunch stop, on your own, on the way. Our first stop will be in Alexandria, VA at the **GW Masonic Memorial** for a tour of this beautiful facility. When we are done, we'll check into our hotel the Hilton Garden Inn Courthouse/Plaza in Arlington VA for the night. After setting in, we'll head to Washington DC for dinner at **Tony & Joe's** along the river. You'll have a *choice of Cheese Tortellini with Parmesan Cream Sauce, Chicken Marsala, Broiled Atlantic Salmon or Pork Tenderloin in a red wine demi glaze*. After dinner, we'll return to our hotel for the evening.

**DAY TWO**- Breakfast is included at our hotel this morning before we visit the **International Temple** of the Order of the Eastern Star - the Perry Belmont House. The block-long beaux arts facade of the historic Perry Belmont Mansion could easily be mistaken for a European palace or a Gilded Age library. And given its location in the embassy-dense Dupont Circle neighborhood most people assume it houses some wealthy diplomatic office. After our tour here, we'll head to the **Pentagon City Mall** where you can get lunch on your own before we start our trip home. Stops will be made enroute for rest stops and we'll return home this evening.
